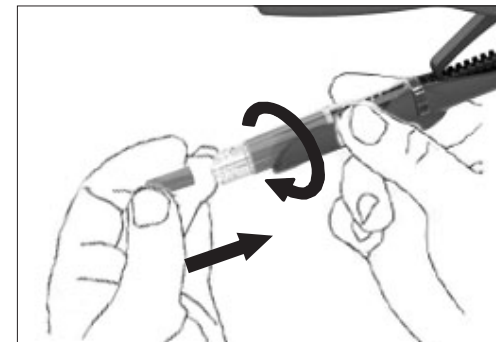

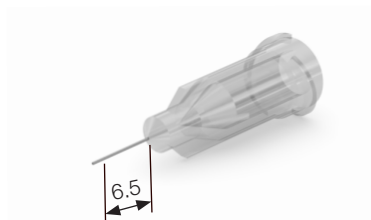
How to use



1. Replace the cap with the needle in the plunger housing.

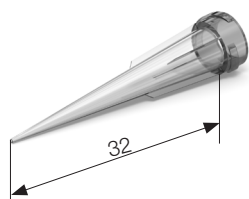
